 - o 91.01 (1) DOMESTIC ANIMALS: Include a limit to domestic animals other than dogs & cats. M
 - o DOG LICENSES ARE BILLED IN JUNE: We have 168 utility services and 127 animals.
 - Consider increasing the animal license fee; currently \$10 M
 - VOTE: To keep 91.04 FARM ANIMALS (chicken) ordinance "as is" or review further. M
 - Note: Bluebird Protective Covenants do not allow any farm animals, this would not override.
 - Continued Review of Chicken Ordinance:
 - Increase the number of chickens from 6 to 10.
 - Limit the number of permits.
 - Include rabbits as equal to chickens and quail.
